Swimming Australia National Insurance Programme

The Swimming Australia National Insurance Programme (“The Programme”) is a joint initiative of Swimming Australia and all State Associations. The Programme has seen a number of benefits provided to all swimming clubs and associations throughout Australia. It is designed to save clubs time, effort and money, as well as provide enhanced insurance cover and risk management services for the swimming community.

COVERAGE

The Programme provides coverage 365 days of the year with an annual renewal date of 1st May.

WHAT’S COVERED

In general, all swimming activities are covered. This includes club events and association meetings, organised club training activities, functions, meetings, and fundraising activities, anywhere in Australia. The Programme provides broad protection across the following areas:
